# • FCASV Policy Priorities for 2017-18

In the 2018 legislative session, FCASV is advocating for amendments to various current Florida statutes to increase protections and support for survivors of sexual violence. Below are outlined and detailed the various changes. During the 2017 session, these amendments were addressed in a comprehensive omnibus bill, SB 1208, filed by Senator Lauren Book, for which no companion bill was filed in the House. This omnibus bill remains a top priority for FCASV in the 2018 session. Some of the sexual assault related bills SART is closely watching:

- ✓ FCASV is advocating for an amendment to the sexual battery statute, F.S. 794.011, to include an offense identifying the touching of an adult in a lewd and lascivious manner as a sex crime.
- ✓ FCASV will be working with legislators to pass an amendment to F.S. 825.101 to include disabled individuals aged 16-17 years to the definition of "disabled person" in order to provide protections for all minor and disabled victims of lewd and lascivious activity
- ✓ FCASV will continue to work to have the relocation statute amended to include protections for some of Florida's most vulnerable victims minor victims of crimes committed pursuant to F.S. 800.04.
- ✓ FCASV supports Marsy's Law and will continue to advocate for provisions allowing victims to be present at all proceedings (not just the public proceedings) and to recognize a victim's right to obtain counsel for representation through the criminal process.

## • 2018 SART Outstanding Member Award

Palm Beach County & Certified Rape Crisis Center is accepting nominations for the 2018 outstanding SART member. The purpose of the SART member is to strengthen relationships, build agency collaborations, and increase communication and clarification that will ultimately result in the best possible outcome for the Sexual Assault victims we serve. The member shall be an individual who has promoted the mission of SART and shown exemplary dedication to the victim centered approach. SART Nominations have been extended and voting will close on March 26, 2018.

New Business: April Sexual Assault Awareness Month activities (SAAM), Kat Duesterhaus

- What were you wearing? Friday, April 6th April 30th April 6 is 6-8 pm is the opening night of the exhibition which will include art created by survivors. PBCVS clients & the Survivor Action Team will create a display of the clothing they wore at the time of their assault. There will be a page with a few sentences next to each contributors clothing describing why the attire had nothing to do with their assault.

- Denim Day: 4.25.18 In this rape prevention education campaign we ask community members, elected officials, businesses and students to make a social statement with their fashion by wearing jeans on this day as a visible means of protest against the misconceptions that surround sexual assault. There will also be a display on our SART fence to honor victims who will write on those jeans to share their messages from outrage to healing.
- Field of Hope: @ SART -5-7pm pass out flyers. This is our "Day of Action Field of Hope" event. We will have an outline of the word "Hope" in huge letters in the field across from our building. Survivors of sexual assault will be writing their statement of hope, healing, anger, anything they wish, on a flag. After the speeches/program, each survivor will have the opportunity (optional) to speak what they wrote & place it in the ground within a letter. There will be vendors, food, and light background music, with survivors, their supporters & general public invited. We expect the Mayor, our WPB Chief of Police & other dignitaries to attend & speak.
- Library Display: Kimberley Small & Jessica Pagan will be on the Library Book Display committee. Display will include: 6 (physical) book displays, Web book list, Web story, Flyers & Posters at the locations with our contact info & services

Seventeen of the exams were conducted at the Butterfly House and eight exams in the emergency room. Three were SANE response no exam.
