Ongoing/New Business:

Bar Project: Coasters - Val & Monica distributed 1000 coasters divided among 4 bars on 4.7.17. Cabo Flats, Blue Martini, Brother Jimmies & Mojito's.

- Rene was told by Susan Williams that a help line call came in the girl got our information off a coaster in a bar.
- Tracey suggested we look into distributing coasters to bars near the college campuses around September
- Monica & Valerie will go to the bars for follow-up. They will see if they got any feedback or information from bartenders, servers, or patrons.

<u>Defensive training</u> - Rene contacted FAU. They directed her to the lieutenant to schedule a training. She has not heard back yet but will follow-up.

<u>Hispanic Clergy Training</u> – SART/Sexual Assault Response Team will hold a training on 6/8 at a Catholic Church. The training will be presented to the church's deacons and priests. The invitation was also extended to other denomination (local Rabbis) to participate.

<u>Safety Videos</u> – We discussed ideas for CAN's next major project. Everyone seemed to like the idea of small (approx. 30 second) videos that discuss safety. These can be posted to our YouTube and social media sites.

- Monica has information on internet safety
- Susan will speak with the FBI and PBSO regarding the safety information they usually present about (and potentially having them present this information to SART as well.)
- Nicole Bishop will be presented a list of safety tips for approval once they are collected
- Channel 20 will need to be contacted to film the clips once all of the information is approved
