# **On-Going Business:** Carol Messam-Gordon

- <u>Prison Release Elimination Act (PREA) Update:</u> Florida Department and Palm Beach County agree to provide services to incarcerated victims of sexual violence in Palm Beach County, in a manner that aligns with the Prison Rape Elimination Act (PREA) standards established by the U.S. Department of Justice, best practice standards in the field of sexual violence victim services, and what is adequate with services available to sexual violence victims in the community at large.
- Responsibilities of the Department: Any time that an incident or allegation of sexual abuse is discovered or reported that requires a the activation of this agreement, the Department will call (if requested by the inmate victim) the County to request a victim advocate respond to accompany the inmate during the sexual assault forensic exam and provide other advocacy services; Provide a 24/7 rape crisis helpline, staffed by certified rape crisis victim advocates; Provide a mailing address for inmate victims to send correspondence; Provide a certified rape crisis victim advocate to respond to requests for advocacy and accompaniment during sexual assault forensic exams and investigatory interviews; Provide follow-up advocacy services and crisis intervention to inmate victims of sexual assault, as resources allow; Provide the Department with the name of the advocate responding to accompany the inmate on the forensic exam, investigatory interview or individual counseling/advocacy/follow-up session; Maintain privileged communication with clients as required by state and federal law and the County's policies;

- Victim Services staff visited SAGO Palm Re-Entry facility to meet staff and to know where they will be responding to provide assistance to victims.
- <u>Florida Council Against Sexual Violence (FCASV) Coordinating Council</u>: The Statewide SART (Sexual Assault Response Team) Advisory Committee is a statewide group coordinated by FCASV and comprised of representatives from a broad range of disciplines whose work brings them into contact with rape survivors. The committee works to assess and improve Florida's response to survivors of sexual violence at the state and local level. The 2016-2017 session of the Statewide SART advisory committee worked together to formulate a report on the systemic response to SA. The committees report will be release in June 2017. #### New Business: Carol Messam-Gordon

• FCASV update 2017 survey results on immigration survivors of sexual assault, domestic violence, and human trafficking: Congress created important protections for immigrant survivors of domestic violence, sexual assault and human trafficking in the Violence against women Act (VAWA) and Trafficking Victims Prevention ACT (TPVA) in the express recognition that abusers often exploit a victims lack of immigration status as a tactic of abuse. Many advocates are hearing from immigrant survivors that they have increased fear and concerns about reaching out for help. In some places advocates are reporting a decrease in immigrant survivors contacting their agencies for assistance. The "2017 Advocate and Legal Service Survey Regarding Immigrant Survivors" was conducted last month by a coalition of national organizations focused on domestic violence and sexual assault.

To better understand these concerns, a coalition of national organizations sent out a survey in April asking for feedback. The group collected responses from 715 advocates and attorneys from 46 states and district of Columbia asking them about the issues confronting immigrant survivors seeking services and information about specific incidents. They found that a majority of respondents are seeing an increase in fear among their immigrant clients, some of whom are fearful of even calling 911 or seeking medical assistance.

•62% of respondents—a group that includes both social and legal services providers—said they have seen an increase in immigration-related questions from survivors;

•78% of respondents said that survivors had expressed concerns about contacting police due to fears that it would open them up to deportation;

•75% said that survivors had expressed concerns about going to court for a matter related to their abuser, a concern that was likely exacerbated by the highly reported courthouse arrest of a domestic violence victim seeking a protective order against her abuser earlier this year;

• 43% of respondents also said that the survivors they have worked with have dropped criminal or civil cases related to their abuse because they were fearful of potentially opening themselves up to enforcement. For further information: <u>survey findings</u>

- Coming Full Circle: Responding to Cases of Sexual Violence Involving Victims with Disabilities; May 26, 2017: John Wilkinson, Attorney Advisor, Dr. Bev Frantz, Temple University and Deputy Chief John Beyer, Duluth Police Department, Retired. Criminal justice professionals were provided a seven-hour training on working to improve their response to crimes of sexual violence for victims having developmental disabilities or other special needs. The training identified some of the unique challenges faced by survivors with disabilities, provided effective resources and strategies for the Seventy-Nine professionals in attendance with tools for investigating and prosecuting their cases. Seven CLEs were provided for attorney's.

#### SART Case Staffing's: Carol Messam-Gordon

• SART case staffing, Jun 9, 2017:

We staffed a case involving a victim who was seen at a local hospital complaining of chest pains and did not initially disclose that she was sexually assaulted. After speaking to the ER nurse the victim disclosed that she was sexually assaulted. Hospital staff immediately called Victim Services, an advocate responded and immediately utilized the victim centered approach realizing that the victim had to be in a private room for the forensic exam. ER was very busy and there were unexpected interruptions making it difficult to maintain the privacy of the victim. The Victim Advocate ran interference to make sure no one entered the room to interrupt or disturb the forensic exam.
